DEFINITION:

Under the general direction of the Housekeeping/Laundry Supervisor, performs related duties associated with the collection, processing, distribution and inventory of linens and personal clothing.

EXAMPLES OF DUTIES:

The duties listed below are examples of work typically performed by an employee in this position. An employee may not be assigned all duties listed and may be assigned duties which are not listed below. *Marginal duties* (shown in *italics*) are those which are **least** likely to be essential functions of this position.

- 1. Responsible for executing work under the direction of housekeeping supervisor and the requests of the nursing staff, in emergency situations.
- 2. Constant alertness to needed repairs and make out work requests.
- 3. Abide by the cleaning procedures
- 4. Handles appliances, equipment and cleaning chemicals in a safe manner.
- 5. Follow all hospital policies
- 6. Responsible for the daily pickups A.M. and P.M. separating, loading and unloading washers and dryers, sorting, folding, weighing and distribution of clean linen, and nursing home patient personal clothing. Folds, loads and records linens and incontinent products onto institutional racks for delivery.
- 7. Responsible for mending all torn linens and patient clothing.
- 8. Operates iron as required.
- 9. Delivers personal and institutional linens to the units as assigned.
- 10. Responsible for daily cleaning of equipment, lint filter on dryer, lint from drain and weekly thorough cleaning of entire laundry and equipment.
- 11. Will assist housekeeping department.
- 12. Ensures quality clothing support services through the maintenance of efficient workflow patterns and in cooperation with other staff, residents and their families. Must demonstrate an ability to work under minimal direction and supervision.
- 13. Maintains a clean and tidy work area and equipment, following cleaning schedules and routines for the department and ensuring the proper care and economical use of resources.
- 14. Protects own health and health of others by adopting safe work practices, reporting unsafe conditions immediately, and attending all relevant in-services regarding occupational health and safety. Follows all Hospital and Department policies and procedures.
- 15. Performs other related duties as assigned.
